

Coding of Underground Optical Cables



Overview

Underground cables are pulled in conduit that is buried underground, usually 1-1.2 meters (3-4 feet) deep to reduce the likelihood of accidentally being dug up. In extreme cold climates, cables may need to be buried at greater depths where there temperatures are colder and frost penetrates to. Underground placement is necessary and unavoidable in certain areas for various reasons such as nature and heritage conservation, natural obstacles, aesthetics, space and safety. Placing cables underground has the added benefits of reducing transmission losses, aiding planning consent and reduced. Selecting the Right Trenching Method Based on Site Conditions Trenching methods should be selected based on soil conditions, site constraints, and acceptable surface impact.
