Standard Color Coding for Warning Signs

Orange is the designated color for warning signs that indicate moderate hazards where serious injury or death could occur if proper precautions are not taken. This includes electrical hazards in distribution boxes, exposed moving parts, or other machinery-related risks. The lettering or symbols on these signs are usually black to provide high contrast and visibility .

Red is reserved for danger signs, which indicate immediate life-threatening hazards, such as high-voltage areas where direct contact could be fatal. These signs are used when the risk is severe and immediate .

Yellow is used for caution signs, which alert individuals to potential physical hazards that could cause minor injuries, such as tripping, slipping, or low-clearance areas. Yellow signs are less severe than orange warning signs but still require attention .

Fluorescent orange or orange-red is specifically used for biological hazards, which is generally not applicable to standard electrical distribution boxes but may appear in specialized environments .

- **Warning: High Voltage** – Orange background with black text or symbol to alert personnel of electrical shock risk.
- **Machine Hazards** – Orange signs may also mark areas with moving parts or pinch points inside or near distribution panels.
- **Mandatory Instructions** – Blue signs with white symbols indicate required safety actions, such as wearing PPE when accessing the box .
