1. Protection and Safety Secondary distribution boxes must be designed to withstand harsh construction environments. - In the UK and US, installations should comply with NEC (National Electrical Code) and OSHA regulations for temporary wiring.
- In Australia/New Zealand, AS/NZS 3012:2019 governs construction and demolition site electrical installations, supplemented by AS/NZS 3000 for general wiring rules.

- All installations must follow local codes for grounding, bonding, and circuit protection. 3. Circuit Protection and Load Management Each secondary distribution box should have circuit breakers rated appropriately for the connected load. Overcurrent protection must match or slightly exceed the conductor rating to prevent overheating . Boxes should allow disconnection of individual circuits, including motors and controllers, with visible disconnects for safety . 4. Cabling and Connectors
 - Use durable, flexible cables such as rubber-insulated or H07RN-F cables, resistant to UV, oil, and mechanical stress .
 - CEE industrial plugs and sockets are recommended for high-power devices, providing robust, moisture-resistant connections .
 - Cable entry and exit points should be protected with insulating bushings to prevent accidental contact with live conductors . 5. Installation and Maintenance
 - Distribution boxes should be easily relocatable to accommodate changing site layouts .
 - Regular inspection and maintenance are required to ensure connections remain secure, breakers function correctly, and no damage has occurred due to environmental exposure .
 - Temporary wiring should be installed to minimize tripping hazards and avoid interference with construction activities . 6. Additional Considerations
 - Include thermal management for high-power modules to prevent overheating .
 - Consider data support if automation or monitoring systems are used on site .
 - Ensure adequate spacing and labeling for circuits to facilitate safe operation and troubleshooting . By adhering to these requirements, secondary distribution boxes can provide a safe, reliable, and flexible power supply for construction sites, protecting both personnel and equipment while complying with relevant electrical standards .
