An EU quota sets a limit on the quantity of a product that can be imported into the EU within a defined period, usually a calendar year, though it can be divided into months or quarters to manage inflow . Within the quota, imports may benefit from reduced or zero duty rates, while imports exceeding the quota are subject to the standard Most Favoured Nation (MFN) duty, which can be significantly higher . Quotas are generally first-come, first-served, and high-demand quotas can be exhausted quickly, so timely customs declarations are critical .

 - Consider trade agreements: Some quotas are negotiated in advance (TRQs), while safeguard quotas can be introduced quickly in response to market conditions .
